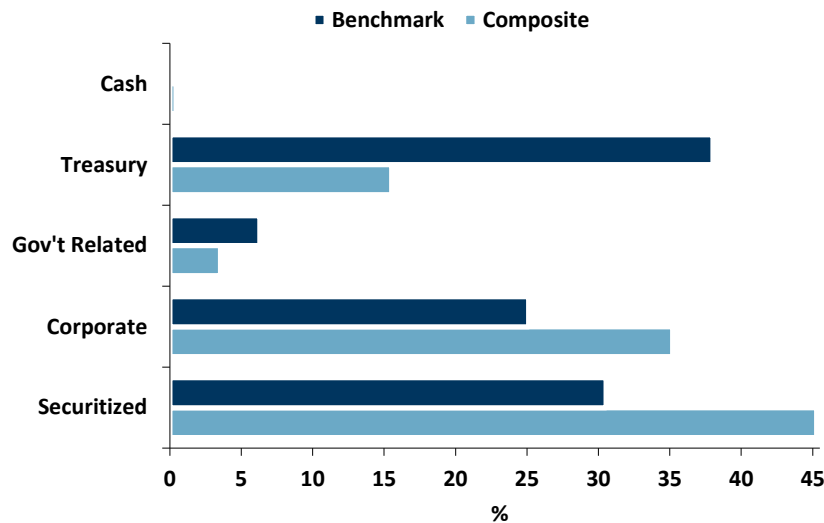
Objective
